

# **\$3 and \$5 Word Play Second Chance Promotion Terms and Conditions**

3. Entrants must mail their non-winning \$3 or \$5 Word Play tickets and an original coupon appearing in *The West Australian* on the above dates. Only original entry coupons published within *The West Australian* and original \$3 or \$5 Word Play tickets sold from Lotterywest retailers are valid. Photocopies and facsimiles are not valid.
