Terms and Conditions

INTRODUCTION

- 1. The following Terms and Conditions apply for the Lotterywest Scratch'n'Win \$5 Cashed Up For A Year (Game 628) top two (2) prizes of win \$5,000 per month for twelve (12) months ("Prize").
- 2. These Terms and Conditions are available at www.lotterywest.wa.gov.au
- 3. To win a Prize players must purchase the Lotterywest Scratch'n'Win \$5 Cashed Up For A Year (Game 628) and find three (3) identical CASH prize symbols in Game 1 or Game 2 or match a WINNING NUMBER with an identical YOUR NUMBER with CASH prize symbol shown in Game 3.

ELIGIBILITY

- 4. Entrants must reside in Western Australia and be aged sixteen (16) years or over to play Lotterywest games.
- 5. To be eligible to claim the Prize the winner must fulfil the above criteria.

PRIZE

- 6. There are two (2) top prizes to be won each of which consists of a fixed gross sum of \$60,000 payable by monthly instalments of \$5,000 for twelve (12) months. The Prize will be paid into the winner's nominated bank account. It is the responsibility of the winner to notify Lotterywest in writing of any changes to the nominated bank account.
- 7. The Prize must be claimed in person from Lotterywest Head Office during office hours, at Level 2, 38 Station Street, Subiaco, WA 6008. The Prize winner must produce the winning ticket and two forms of identification in which one item needs to be a photo identification and one needs to show a current address in Western Australia, in order to collect their Prize.
- 8. The Prize must be taken as twelve (12) monthly instalments.
- 9. The first instalment of \$5,000 will be paid after verification that the ticket is a winning ticket and after a 14 day validation period. Each subsequent instalment will be paid on the 15th day of each following month for a period of eleven (11) months, to a total of twelve (12) payments.
- 10. The Prize, is not transferable or assignable.
- 11. If a Prize winner dies during the twelve (12) month period, then Lotterywest will continue to pay the instalments into the nominated account until formally notified in writing by an appropriate legal authority of the claimant's estate details, at which time Lotterywest will pay the remaining portion of the unpaid prize in a lump sum to the claimant's estate.
- 12. Prize winners should seek independent financial advice about any tax implications that may arise from winning the Prize.
