Terms and Conditions

INTRODUCTION

- The following Terms and Conditions apply for the Lotterywest \$10 Prestige Wheels (Game 852) in which three (3) Mercedes GLC 300 4M FL Wagon Model 25398422-AU3 (X253) AU ("Prize") vehicles are offered.
- 2. These Terms and Conditions are available at <u>www.lotterywest.wa.gov.au.</u>
- 3. To win a Prize, players must purchase the Lotterywest \$10 Prestige Wheels (Game 852) and either:
 - a. Match a WINNING NUMBER with an identical YOUR NUMBER and reveal the corresponding prize of GLC 300 or
 - b. Reveal the number plate GLC 300 on the Bonus play area.

ELIGIBILITY

- 4. Entrants must be aged sixteen (16) years or over to play Lotterywest games.
- 5. Entrants must reside in Western Australia (WA) in order to be eligible to win a Prize.

PRIZE(S)

- 6. There are three (3) top prizes to be won each of which consists of a Mercedes GLC 300 4M FL Wagon car. Each prize is valued at AUD \$98,984.76 which is inclusive of GST, dealer delivery fee, stamp duty, luxury registration fee, and WA registration costs. Lotterywest accepts no responsibility for any change in prize value between the date the competition period commences and the date on which a Prize is won or redeemed.
- 7. A Prize must be validated in person with the winning ticket from Lotterywest Head Office during office hours, at Level 2, 38 Station Street, Subiaco, WA 6008. The Prize winner must produce the winning ticket and two forms of identification in which one item needs to be a photo identification and one needs to show a current address in Western Australia. Lotterywest will then provide the winner with a validation letter to present to the Mercedes dealership ("the Dealer) as nominated by Mercedes Australia.
- 8. A Prize must be collected by the winner from the Dealer once a Prize has been validated at Lotterywest Head Office. The nominated Dealer for collection is not transferable or negotiable. Lotterywest will contact the Dealer to confirm the identity of the winner. The winner must produce photo identification to the Dealer in addition to the Lotterywest validation letter to collect a Prize. It is the winner's responsibility to arrange delivery of the vehicle directly from the Dealer. The Mercedes GLC 300 4M FL Wagon Prize model awarded may differ from the image(s) used on the ticket or in promotional materials, which are for illustration purposes only.

 - a. Current production model
 - b. On road costs
 - c. Pure White paint (depending on availability)

- d. Dealer delivery, stamp duty and twelve (12) months WA registration including compulsory third-party insurance and dealer delivery charges (which may vary State by State).
- 10. A Prize excludes:
 - Any additional extras not included in the Mercedes GLC 300 4M FL Wagon specifications in Clause 9 above. Extras can be added and paid for by the winner at the time of claiming a Prize from the Dealer;
 - b. Vehicle Insurance. The winner should ensure adequate vehicle insurance is available before collecting the vehicle from the Dealer; or
 - c. Transport to and from the Dealer to collect a Prize;
 - d. Any costs or damages related to fuel, paint, mechanical damage or other from the date of delivery.
- 11. If for any reason a Prize is no longer available at the time it is claimed, Lotterywest may at its discretion substitute AUD \$85,985 (exclusive of GST and any dealer discount Lotterywest would have obtained on the bulk purchase of Prizes) for a Prize.
- 12. Lotterywest and the Dealer will not be liable to a prize winner or any other person in any way and accepts no responsibility for any accident, loss, injury or damage to any individual or property in relation to a Prize except for any liability that cannot be excluded by law.

- 15. All prizes are valued in Australian dollars and are correct at the time of printing.
- 16. Prizes may be subject to further conditions as determined by Lotterywest and the Dealer, and the winner must agree to these conditions upon accepting a Prize. Prizes are also subject to normal Lotterywest Scratch'n'Win prize claim rules as specified on the website.
